

## MHSIBCA General Membership Meeting - Minutes of September 18, 2004

Meeting was called to order at 10:00 a.m.

Randy Allen provided an update from the MHSAA on Rules for the 2004-2005 season. This included the mandatory Rules Meeting that all Head Coaches must attend for the upcoming season.

### Under “Accept Agenda and/or Stipulate Additions:

Letters E (MHSAA Mandatory Coaches Rules Meeting) and H (Rules and Regulations for the 2004-2005 Season) were deleted as they were covered by Randy Allen’s presentation.

Mike Roach moved to accept the minutes from last meeting as printed, seconded by Ted Kress. Motion carried unanimously.

Tom Stockton moved to accept the financial report as printed (with the addition of a date for the beginning balance), seconded by Vicky Krueger. Motion passed unanimously.

### Under “General Comments/Discussion of the Past Season”:

Ron Tomassoni displayed and encouraged others to have a Handbook that is distributed to all coaches and Athletic Directors.

Dave Kowalski provided another solution for YABA bowling. His Conference bowled on Saturdays after YABA bowling which meant that only one meet was held instead of two.

Harry Burkey encouraged coaches to spread the word about the MHSIBCA web site ([www.mhsibca.com](http://www.mhsibca.com)).

### Under “Report of Standing Committees”:

The following Committee Reports were heard:

1. Zero Tolerance: Committee Chair Person, Gloria Gostovich, was unable to

attend the meeting but sent a written report with several suggestions. Tracy Long moved to “Raise Membership fees by \$10.00 to cover an ‘I Chat’ fee,” seconded by Vicky Krueger. After a discussion, the motion failed to pass. Dave Kowalski moved that “We use the USA Bowling Coaches Association’s stance on Zero Tolerance and amend it to fit our Association.” Motion was passed with one NO vote.

2. Clinics: Committee Chair Persons, Becky Arend and Dennis Arend were unable to attend due to health reasons, and Ted Kress moved to “Table the report until the next General Meeting,” seconded by Paul Bentley. Motion passed unanimously.

3. Constitution/Bylaws and Nominating: Committee Chairperson, Rhonda Pfromm was not in attendance and did not submit a report. A new committee was appointed by the President (Jim Salwedel, Joyce Washburn and Jim Pellerito).

4. Regional and State Finals: Chairpersons Bob Longrey and Mike Roach did not have a report as they felt a report should be made at the next General Meeting. Tom Stockton moved to “Have a form developed to pass out to coaches that must be turned in at the Regional Sites,” seconded by Judy Jaeger. Motion passed unanimously.

5. All-State Team Selection: Tom Stockton presented a written report with a list of criteria for the All State Team Selections. After two discussion periods, Jon Epple moved to “Accept the criteria for All State Team Selections as amended,” seconded by Mike Roach. Motion passed with on NO vote.

6. All State Coach Selection: Tom Stockton asked that this committee have more time to present a more thorough report to the Association via e-mail and/or direct mail. Jim Pellerito moved to “Have it referred back to committee with a report to be made via e-mail and/or direct mail,” seconded by Dave Kowalski. Motion passed unanimously.

Under “Old Business”:

There was no Old Business to discuss.

Under “New Business:”:

Jim Pellerito moved that “A coach must be a member of the MHSIBCA by February 1 in order to submit a student from his/her team to be considered for All State Team Selection,” seconded by Joyce Washburn. Motion passed with two NO

votes.

Tom Stockton moved to “Continue a Michigan High School Interscholastic Bowling Coaches Association Hall of Fame beginning with those members inducted in the original High School Bowling Hall of Fame (those inducted were Ron Tomassoni, Scott Bennett, Greg Gumtow, Matt Fioritto, and Mike Martus),” seconded by Ted Kress. Motion passed unanimously.

Jim Pellerito moved that “The Executive Board address the issue of a 501c and give a report at the next general meeting,” seconded by Jon Epple. Motion passed with one NO vote.

Ron Tomassoni encouraged coaches to download two Handbooks (a Coaches Guidebook from the MHSAA web site and a High School Bowling USA Guidebook from High School Bowling USA).
