## Tournament Rules:

1. The Gavie Youth Tournament is open to all youth bowlers who are Youth USBC certified. A bowler cannot be 20 years old, as of August 1<sup>st</sup>, 2017 of the current season to participate. This is a USBC-certified scratch singles tournament.
2. The Rules of the USBC will govern all contestants. The Tournament Director will determine matters not covered by those rules. All decisions will be final unless an appeal is made in accordance with Rule 329.
3. Entries must be paid in advance. No reserved entries. Checks are to be made out to **TURBO GRIPS**. We will not be responsible for cash sent through the mail. Entry forms that cannot be read or have no entry fees will be returned. Entries are limited to 96 paid bowlers, regardless of division on a first come-first served basis. Checks returned for insufficient funds will be assessed a \$35.00 fee.
4. The pre-paid cost (post marked / received on or before Monday, September 25, 2017) entry fee is \$40.00 per bowler. Lineage/Expense Fees - \$11.00, Scholarship Fees - \$29.00. Awards are presented on a 1:4 ratio in both divisions. Scholarships awarded will be administered by the USBC Smart program. A minimum GPA of 2.0 will be required to receive funds. Winners of door prizes must be present to win. Entries received after September 25, 2017 will be assessed an additional \$10.00 late processing fee. Walk-in (day of tournament October 1, 2017) entries (accepted depending on lane availability) will be assessed an additional \$10.00 late processing fee. The closing date for paid entries is Sunday, October 1, 2017.
5. **Tournament Format:** There will be 2 separate divisions in this tournament; the Male division and the Female division. The format is the same in both divisions, except where noted. **Qualifying Round:** All bowlers will bowl a 6-game Qualifying Round. The top fifty percent (50%) of the bowlers in each division, based on the 6-game series score from the Qualifying Round, will advance to the **Championship Round**. In the event of a tie for any other position, the bowler with the highest game will be placed in the higher position. Should a tie still exist, then the next highest game will be used. In the case of a tie for the final place, an additional roll-off of the 9<sup>th</sup> and 10<sup>th</sup> frames will be conducted by those bowlers tied. The bowlers with the highest game will have lane choice. The bowler on the odd lane will start the roll-off. If a tie exists after the roll-off, an additional roll-off of the 9<sup>th</sup> and 10<sup>th</sup> frames will be conducted. Bowlers will begin the roll-off on the lane on which the bowler finished the previous game. As in all other games, the bowler on the odd lane will start. **Championship Rounds:** The scores from the Qualifying Round will be dropped. The Championship Rounds will consist of games bowled against the remaining field with bowlers “eliminated” after each game. **Round 1:** the top fifty percent (50%) of the bowlers in each division. **Round 2:** the top fifty percent (50%) of the bowlers in each division. **Round 3:** the top fifty percent (50%) of the bowlers in each division. **Round 4:** the top fifty percent (50%) of the bowlers in each division. **Round 5:** the top fifty percent (50%) of the bowlers in each division. All ties for advancing positions in the Championship Round will be broken by a 9<sup>th</sup> and 10<sup>th</sup> frame roll-off. **Placement:** Final tournament standings in the Championship Round will be based on the score rolled by a bowler in their last Championship Round game.
6. If the tournament fills before the deadline date and withdrawals occur, vacancies will be filled based on postmark of date entry received.
7. **TOURNAMENT NO SHOWS.** If you enter the tournament and don't show, you forfeit your entry fee. If you call and cancel a minimum of 24 hours before the squad, your entry fee will be refunded minus a \$10 service fee subject to tournament committee discretion.
8. The Tournament Committee may impose a 30 second rule and limit re-racks to two per game.
9. Dress code required: A collared shirt or a mock-collared shirt made of “dri-mesh” fabric is required with dress pants. Shorts/skirts may be worn provided they pass the “fingertip-length” test. No hats, sunglasses, or non-medical headgear. No handheld electronic devices (including Ipods, Ipad, and cell phone) are permitted while tournament is in progress.
10. All bowlers must keep their poise during the tournament. Abuse of equipment, foul or disruptive language, gestures, and/or unprofessional behavior by bowlers or spectators are cause for the non-refundable dismissal from participation or attendance at this tournament by the tournament committee discretion. Any damage to the bowling center equipment shall result in disqualification from the tournament plus payment to the center for the damage incurred.
11. Tardy bowlers will receive a zero (0) score for all frames missed. All bowling equipment must meet USBC standards. Equipment may be spot checked at any time, any equipment found not in compliance on the check, the bowler will be disqualified immediately. The use of powder or any foreign substance on shoes, the approach, or on the facility floor or carpet is not permitted. The use of boric acid or any abrasive that has to be self-contained is prohibited. Anyone caught using any of the above shall be disqualified. No altering of surface of any ball once competition begins.
12. No smoking, drinking of alcoholic beverages, chewing of snuff or tobacco, or using any controlled substances (that is not under a current prescription) by any bowler during times that bowling is taking place. Violators shall be disqualified. Anyone who is caught with controlled substances (drugs, et al) will be turned into the proper authorities.
13. Only participating bowlers and tournament officials are allowed in the bowler's area.
14. **ALL PROTESTS ARE TO BE MADE BY THE BOWLERS, OUTSIDE OBJECTIONS (PARENTS, ETC.) WILL NOT BE HEARD. WE RESERVE THE RIGHT TO ASK ANY PERSON TO LEAVE THE BOWLING CENTER IF THEIR CONDUCT IS DETRIMENTAL TO THE TOURNAMENT OPERATION.**
15. The Tournament Committee has the right to refuse any entry. The bowler, by voluntary participation in the event, acquiesces to the final authority of the Tournament Committee to interpret and enforce all rules, regulations, and procedures. Any foreseen or not described situation(s) will be regulated by USBC rules with interpretative judgment guided by the best interest of youth bowling and this event.
16. In the event of War, Fire, Flood, Storm or any act of God which makes it impossible to conduct the tournament, any entry fees paid up to that time will be returned in full.
