

Amendment 2020-1: Contingency Proposal - Language change even to odd year, odd to even year

Amending Article V, Section 1 and Article VI, Section 3 as detailed below.

Rationale: Due to the uncertainty in the world. The legislative committee with the support of the association feel if, there will not be a season the newly elected board members would be cheated out of being able to serve a full 2 year term. These newly elected members would be in their positions in name only. The current full board would add an additional year to their current 2 year term. Again, this is strictly a contingency option if we fail to have a season.

Legislative Committee Recommendation: The Legislative Committee recommends that this amendment BE adopted.

Action: If this amendment is approved by two-thirds majority of members attending the Annual General Meeting, then the adopted amendment will go into effect upon cancellation of the 2020-21 MHSAA bowling season. Association Bylaws and Policy and Procedures Manual will both be updated and posted.
