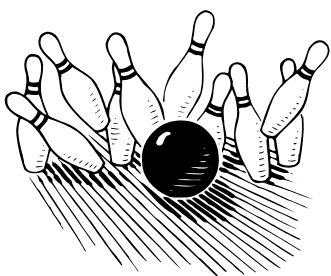

Richard Hochstein, proprietor of Wonderland Lanes for almost 50 years, passed away on March 5, 2015. Richard held a very large role in the Walled Lake High School Bowling Program for many years. Richard lived for his family, friends and community, and put a smile on the face of everyone he met. The Richard Hochstein Scholarship Fund was set up in Richards honor. This fund offers a scholarship opportunity to the bowlers who plan to attend an accredited college or university while continuously acting as a positive role model in the community. This recipient will carry on Richards legacy of treating people with respect at all times and making a positive difference in the people around them.

Rules:

1. MHSAA rules and USBC regulations will govern this tournament.
2. This event is open to the first 18 high schools (36 Teams, 18 boys, 18 girls) that have a varsity team in high school competition.
3. All scholarship monies are paid in USBC points
4. Only registered bowlers may bowl. Active team is five bowlers plus two alternates (7 total) as listed on the entry form.
5. Bowlers may only compete for their school as listed and verified on the entry form.
6. Only official, registered bowler names may be used on scoring line-up
7. All teams shall bowl scratch (no handicap).
8. Each school may enter one boy and one girl team. A full fee is charged for each team.
9. Team entry fees paid to **Richard Hochstein Memorial Scholarship Fund**.
- 10. Please ask for NEW W9 to give to your district**
11. All coaches (or designated coaches) will be required to sign score sheets. Errors in scoring must be reported to the tournament director immediately. Any changes in scoring can only be made by the tournament management.
12. Teams will check in the tournament office when all members of the team are in the bowling center. Bowlers should report not less than one hour before squad time.
13. Bowlers should bring their own equipment, especially shoes if possible
14. All equipment used in the tournament must meet USBC/MHSAA specifications. Illegal equipment will constitute a forfeit and scores for that event shall be disallowed
15. Only registered bowling team members will be allowed in the immediate bowling area.
16. One division for boys and one division for girls.
17. Three regular games and four Baker games to qualify. Substitutions will be allowed per MHSAA rules.
18. If a tie after qualifying exists, Teams will bowl ONE baker game to determine winner
19. Lanes are pre-assigned by the tournament committee prior to check-in
20. Match play will be best 2 out of 3 baker games. Ties will be total pins. If tie still exists, 6-10 frame roll off to break tie.
21. First place for both divisions will receive a traveling trophy to be brought back next year.
