REGISTRATION INSTRUCTIONS AND TOURNAMENT FORMAT

Registration Instructions

1. Teams may pre-register by emailing PCSBowlingTournaments@gmail.com
2. Registrations will be accepted in the order in which they are received. In the case of mailed registrations, the postmark date will be used.
3. Until all interested teams are registered, no school will be allowed more than one team in each division.
4. Once registrations exceed available spots, a waiting list will be kept.
5. All registrations will receive a confirmation email.
6. Rosters are not required at time of registration but must be submitted no later than **Monday, January 6, 2025**.

Tournament Format

1. This event will be contested on the 24/25 Season PHANTOM pattern
2. Teams will be assigned lanes on a random draw.
3. Fifteen minutes of practice will be allowed prior to the start of the first game.
4. Athletes will bowl three (3) games and two (2) baker matches on five (5) different pairs of lanes. Follow lane assignments on the recaps. Competitors are asked to observe one-lane courtesies.
5. After completing 3 regular games, teams will move again for the first baker match (2 baker games) and then one more time for the last Baker Match (2 baker games). Please follow lane assignments on the recap sheet.
6. The Baker Format uses the lead-off bowler to bowl frames 1 and 6, the second bowler to bowl frames 2 and 7, and so on. The position of each bowler in the line-up may be changed for each game.
7. Once all baker games have concluded, scores will be tallied to determine the winners in each division according to total pinfall.

TOURNAMENT RULES AND REGULATIONS

1. MHSAA and USBC rules and regulations will govern this tournament.
2. **Closing date for entries is MONDAY, January 6, 2025**
3. This event is open to all current high schools that have a varsity or junior varsity team entered in MHSAA competition for the 2024-2025 high school bowling season.
4. Only registered bowlers may participate. An active team shall consist of five bowlers. Up to two alternates are permitted. Substitution will be allowed as follows:
 - a. Starting bowlers must bowl at least one frame in a given game.
 - b. Once a substitute enters the game, he/she must complete that game.
 - c. Mid-frame substitution is permitted.
 - d. The bowler who has been substituted for must sit out the remainder of that game but is allowed to return as a starter or a substitute in subsequent games.
 - e. The substitute must be on the original tournament roster.
5. Entry fee is \$135 per team. There are no refunds. Checks returned for insufficient funds will be assessed a \$40 fee. A bowler may only bowl for his/her school. School ID is required and should be with the bowler at all times.
6. This is a scratch tournament. No handicap.
7. All coaches will be required to sign score sheets. Any scoring errors must be reported to the tournament director immediately. Only tournament officials can make score changes.
8. No prize money will be collected or awarded. Awards will be presented to the top team in each division. Medals will be awarded to the top three games/series in each division for both boys and girls. Individuals will receive medals for all qualifying scores.
9. Teams are required to check in at the tournament office one hour prior to the start of tournament competition.
10. All equipment used must comply with USBC regulations. Use of illegal equipment will constitute a forfeit and scores will be discarded.
11. Bowling Attire: All Bowlers should be dressed alike in shirts and the same color pants. School shirts must reflect the name of the school and or the school logo or mascot. Hats, jeans, leggings and sweatpants are prohibited.
12. Only registered bowlers and coaches are permitted in the bowling/settee area.
13. Any bowler/team arriving after the start of competition shall begin play in the game/frame currently being bowled. Makeup of missed frames is strictly prohibited.
14. No alcohol or tobacco products, including e-cigarettes, vaping or other smoking devices. Outside food or drinks are not allowed.
15. Bowlers will not be permitted the use of amusement games, pool tables or mobile devices (iPhones, ear buds, mobile gaming, etc.) during their team's competition.
16. **Bowlers, coaches and spectators** will be expected to conduct themselves in the spirit of fair and honorable competition. Unsportsmanlike conduct (including but not limited to profanity, rooting against competition, etc.) will not be tolerated under any circumstances. Penalties will be enforced up to and including forfeiture of tournament placing and refusal of entry for future competitions.
17. Any disputes during the tournament or exceptions to the above rules and regulations will be resolved at the discretion of the tournament officials. All such decisions are final.
