FORMAT

Tournament format will be three (3) individual games followed by four (4) baker games in the qualifying round. The top eight (8) boys and girls qualifying scores will advance to the match play round that will consist of two (2) game total pin fall baker's game match. In the event of a tie, the roll off will continue as frames 6-10. In the event the score remains tied it will then be a two frame (9th and 10th) roll off with the bowlers that bowled the 9th and 10th frames, from the previous roll off, bowling these frames.

RULES

MHSAA rules and regulations will govern this tournament.

This event is open to all high schools that have a **Varsity** or **JV team** in high school competition.

Active team is five (5) bowlers and two (2) alternates.

Only official and registered bowlers may be used on scoring lineup.

All teams shall bowl scratch (no handicap).

Each school may enter up to **two boys and two girls teams** (full fee for each).

Only registered bowlers are allowed in immediate bowling area.

One division for boys and one division for girls.
